COVID-19 OUTBREAK: INDUSTRY COMMUNICATION FROM THE SIERRA LEONE CIVIL AVIATION AUTHORITY (SLCAA).

His Excellency the President Rtd Brigadier Julius Maada Bio, declared a State of Public Health Emergency in Sierra Lone on the 19th March 2020, followed by a restriction on air travel for all International commercial Flights, in a bid to prevent the spread of COVID-19 in the country.

Further to our earlier letters on the above subject, the SLCAA wishes to share some key business decisions taken in order to optimize its services for the Civil Aviation industry during this period.

PROVISION OF PERSONNEL LICENSING SERVICES.

a. Validity of Personnel Licenses.

- No new aviation personnel licenses will be processed or issued during this period.
- All personnel whose licenses are due to expire after 31st March 2020 can exercise the privileges of their licenses for an extended period of up to 30th June 2020.

This provision applies to the following;

- Air Traffic Controller
- Designated Examiners

All Medical certificates will be extended for a period of up to 30th June 2020.

- Class 1, 2 and 3 Medical certificates holders who have Limitations or are under additional medical surveillance by the Authorised Aviation Medical Examiner (AAME) or SLCAA should continue to comply with the specified requirements imposed. Failure to do so may invalidate their Medical Certificate and/or the applicability of this exemption to them.

The exemptions listed above will have its limitations and conditions to ensure safe operations. The limitations will amongst others include, no known medical conditions and service provider mitigation plans.

2. GENERAL AVIATION SERVICES.

- No new applications or ongoing applications for Remotely Piloted Aircraft Systems (RPAS) Operator Certificate shall be processed during this period.
- The Authority will issue an extension enabling RPAS permits holders whose permit expire between 31st March 2020 to 30th April 2020 to exercises the privileges of their permits for an extended period of up to 30th June 2020.
- All permits expiring between 31st March 2020 and 30th April 2020 are granted extension up to 30th June 2020.

ACTION REQUIRED:

Applications for special permits shall be submitted with necessary documents to; the **Director General**, **SLCAA** at <u>info@slcaa.gov.sl</u>.

3. ECONOMIC REGULATORY SERVICES.

- Pending applications for grant/renewal of licenses/permits/certificates are suspended until further notice.
- No new applications or ongoing applications shall be processed during this period.
- Aircraft clearances for essential and emergency flights as approved by the Honorable Minister of Transport and Aviation shall be processed.
- Payments of fees arising from SLCAA's Economic Regulatory Services shall be made upon prior collection of electronic invoices.

4. GENERAL COMPLAINTS AND ENQUIRIES ABOUT SERVICE DELIVERY BY AVIATION OPERATORS-CONSUMER SERVICES.



5. AVIATION SECURITY OVERSIGHT.

All Certified Aviation Security Screeners, and Approved AVSEC Instructors whose certificates or approvals that are expired or due to expire from 30th March 2020, are extended to 30th June 2020.
