

SLCAA DG PAYS COURTESY VISIT ON THE TURKISH AMBASSADOR



The Director-General of Sierra Leone Civil Aviation Authority (SLCAA), on Friday, paid a courtesy visit on the Turkish Ambassador to Sierra Leone, His Excellency Deha Erpek.

It could be recalled that the Government of the Republic of Turkey and the Government of the Republic of Sierra Leone signed a Bilateral Air Service Agreement (BASA) in Mumbai, India on 22nd October 2011, desiring to facilitate the expansion of International Air Service opportunities, recognising that efficient and competitive international air services could enhance economic growth, trade, tourism, investment and the welfare of consumers.

In his presentation, the DG Baio expressed his profound thanks and appreciation to the Turkish Ambassador for the operation of the Turkish Airline in Sierra Leone.

The Director-General further informed the Ambassador that Sierra Leone has been scheduled for the ICAO Universal Safety Oversight Audit Programme (USOAP) in November this year. establishment and currently providing a storage facility for most of their equipment.

"The State will be audited as against November, we would not want to fail this audit because if we fail it will tell on the economy of the nation, and it will affect airlines operating in Sierra Leone, and Turkish Airline is one of those operating in Sierra Leone."

The Turkish Ambassador to Sierra Leone, HE Deha Erpek, in his response, commended the SLCAA for the strides taken in making the aviation Industry in Sierra Leone very competitive. HE Deha Erpek disclosed that they were ready to support the SLCAA in passing the scheduled ICAO Safety Audit.





MTA HOSTS THE NATIONAL AIR TRANSPORT FACILITATION COMMITTEE



Ministry of Transport and Aviation (MTA) on Monday hosted the National Air Transport Facilitation Committee to discuss issues surrounding the passenger experience on arrival at the Freetown International Airport.

The main purpose of the meeting was to review the travel process at the Arrival Hall of the Freetown International Airport (FNA), identify gaps and bring out suggestions to address the gaps highlighted.

The Minister of Transport and Aviation, Hon. Kabineh Kallon, in his remarks, revealed that government was concerned about the state of affairs on the facilitation process implemented at the Freetown International Airport Lungi, adding that there were few concerns from the travelling public which, he believed, the committee should address.

"Since the reopening of the airport, I am pleased to inform you all that government is satisfied with the collaboration and cooperation between NaCOVERC and the Aviation Industry Stakeholders. The passenger processing on the arrival at FNA has posed very serious challenges for which we consider it as a cause for concern, which has the tendency to mitigate our desire to fly in or out of the country," the Minister said.

The Hon. Minister ended by calling on the committee to provide solutions to these problems and see how they could make the Air Transport Sector attractive and lively once again.

Giving the overview of the National Air Transport Facilitation Committee, the SLCAA Director-General, Moses Tiffa Baio noted that the National Air Transport Facilitation Programme was from our national laws, which was also a transposition from Annex 9 of the Chicago Convention of the International Civil Aviation Organization (ICAO).

"Principally, this talks about the expeditious movement of passengers in and out of the Freetown International Airport. But then, the emergence of COVID-19 has added another burden on the travelling public which is something we are not averse to some of the stringent measures that have been implemented as a result of the COVID-19 pandemic. What other airports are trying to do is to make sure that passengers travelling to different destinations do not experience more air travel ordeals," DG Baio observed.

DG Baio further stated that the Aviation Industry was struggling to get people back to flying and the committee's primary focus should basically look at some of the public health measures implemented at the airport.

"Specifically, we are looking at the arrival process from the moment passengers disembark from the aircraft go through the health protocol, the additional screening is done by SECURIPORT, Immigration, Customs, NaCOVERC and onto the last point in crossing over to Freetown without compromising the health protocols put in place, we need to see how best we can address some of these concerns from the travelling public," the DG said.

DG Baio reaffirmed that the Civil Aviation Authority was charged with the responsibility of implementing Annex 9 of the Chicago Convention of the International Civil Aviation Organization (ICAO). He concluded by admitting the Aviation Industry was glad that the issue of collecting passports from arriving passengers had been rescinded.


On the side of NaCOVERC, Col. Hassan Coomber, Operations Pillar Lead disclosed that they have been doing fine in terms of COVID-19 restrictions even though there is still a need for improvement. "We have taken off the interdistrict restriction, as well as giving access to all passengers travelling through the airport," Col. Coomber stated.

Col. Coomber also expressed there had been overcrowding at the airport and this, according to NaCOVERC, is an alarming concern for the transmission of the virus. Based on this worrying development, he added, NaCOVERC had been engaging key stakeholders on the need to have a seamless process at the airport.

Representing the Sierra Leone Airport Authority (SLAA), the Deputy General Manager, Bobson Kargbo informed the Committee on the introduction of key health measures implemented at the airport to help prevent the spread of the COVID-19 pandemic. the Deputy GM added: "We have made it mandatory to wear a face mask at the airport. We have also installed handwashing facilities within the airport. We will also be embarking on massive public education to inform the travelling public about the health protocols that have been put in place."

On behalf of the Board of Airlines Representative (BAR), Estelle Van Eeckhout from Brussels Airlines confirmed the airport's congestion, adding that: "For the passenger Health Locator Forms (HLF), some Airlines do give it onboard the aircraft but we have noticed that the information they fill on the HLF is the same with what they filled on the travel portal," Estelle said.

The committee resolved that the SECURIPORT data collection system be merged with the Ministry of Health and Sanitation DHIS 2 system, to mitigate the duplication of data collection at the airport.







SLCAA ENGAGES STAKEHOLDERS ON TRAVEL GUIDELINES AT FNA



The Sierra Leone Civil Aviation Authority (SLCAA) has engaged NaCOVERC, Board of Airlines Representatives (BAR) and Sierra Leone Association of Travel Agents (SLATA) on the implementation of the health protocol guidelines for seamless operations at the Freetown International Airport (FNA).

SLCAA's Director-General, Moses Tiffa Baio, in his address expressed that the implementation of some of the COVID-19 measures at the Freetown International Airport has negatively affected the traveling public.

"When passengers are tested positive for Covid-19, they do have challenges with their tickets changed to another date either by the Airlines or Travel Agents. Most of these passengers also do forfeit their tickets for failure to pay the additional cost" DG Baio said.

The DG further mentioned that stakeholders should not look at the technicalities surrounding the process of changing tickets, rather, the best interest of the travelling public who are the consumers of their products.

The DG further mentioned that stakeholders should not look at the technicalities surrounding the process of changing tickets, rather, the best interest of the travelling public who are the consumers of their products.

"Yes, the implementation of some of these health protocol guidelines have negatively affected the travelling public and citizens are crying out loud," he lamented.

DG Baio called on stakeholders to develop a travel bulletin to give to passengers who are tested positive of COVID-19, as it will further guide them on the next step in an event, they are tested positive of the virus. He further encouraged stakeholders to also embark on massive public education which he believes would help address the many concerns from the travelling public.

"Since the re-opening of the airport in July 2020, we have been doing very well within the subregion and the Government is very much pleased with the collaboration within the Aviation Industry," DG Baio ended.

Representing NaCOVERC, the Deputy Minister of Social Welfare Hon. Mohamed Haji-Kella, who also doubles as the Psycho-Social Pillar Lead at NaCOVERC, started by sharing stories of passengers who are victims of this unfortunate situation.

The Hon. Deputy Minister expressed that NaCOVERC was very much thankful for the collaboration within the Aviation Industry since the re-opening of the airport, and they were ready to give the necessary support to the industry.

Responding on behalf of the BAR, Estelle Van Eeckhout from Brussels Airline revealed that there were more flexible tickets that could be changed free of charge and those not so flexible.

She furthered that Airlines did have an integrated revenue management system that was automated and controlled by their different head offices, and that changing those tickets was not as easy as passengers would think.

"When passengers are asked to pay a certain sum for a ticket that has been issued, it is not the change fee but rather the fare difference for the available seat as the case may be. This fare regime is the same for all airlines. Some tickets can only be changed by the travel agents through whom they were purchased" she maintained.


Estelle ended by calling on passengers to immediately inform the Airlines or the Travel Agents from which they purchased their tickets once they have been tested positive of COVID-19.

On the side of SLATA, the Interim Chairman, John E Rogers assured stakeholders that he would communicate the outcome of the meeting to the entire membership and would ask travel agents to display the health protocol guidelines on their notice boards for ease of reference.

"At the moment, we are also trying to have a hotline so that passengers can call should there be any challenge with their tickets thereafter," he disclosed.

The meeting resolved that Passengers testing positive should immediately call their Airlines and inform them, so that arrangement would be made for a reservation after the mandatory 14 days quarantine.

ICAO AND SLCAA DISCUSS IPACK DEPLOYMENT



The International Civil Aviation Authority (ICAO) has engaged the Sierra Leone Civil Aviation Authority (SLCAA) on the Deployment of iPack to strengthen the National Air Transport Facilitation Programme (NATFP).

The objective of the meeting was to support the strengthening of the National Air Transport Facilitation Programme for the restart and Resilience of Civil Aviation implementation package (iPack).

iPack is a bundle of standardized guidance material, training, tools, and expert support which aims to facilitate and guide the implementation of ICAO provisions for State entities (e.g., Governments, Civil Aviation Authorities, National Air Transport Facilitation Committees), aviation service providers, supply chain stakeholders and their personnel.

On behalf of ICAO, Christian Bechtold, the Field Project Officer while thanking participants of the Zoom Video Conference, revealed that this was the first iPack to be rolled out within the sub-region. He disclosed that the Project Expert would work with the SLCAA on how to address these components according to the specifics of the need's analysis.



"Let me further inform you that there are three main components of iPack: Facilitation training, Documentations which will be made available to the SLCAA team, and the Implementation support," he said.

"The expert is there to provide recommendations to the State during the iPack implementation, the SLCAA will in turn work on these recommendations and make the different changes that are suggested. Successful implementation of the iPack will depend greatly on SLCAA's ability to follow these recommendations." he underscored.

He continued on the roles and responsibilities: "The main work will be done between the Expert and the CAA with contacts of the different activities. Technical support will also be provided by the ICAO Regional Office in Dakar, Senegal."

Christian ended by noting they were going to review the need's analysis questionnaire that had been developed by the SLCAA. Based on the outcome of the review, he furthered, the Regional Officer together with the Facilitation Officer from ICAO Headquarters would determine which objectives they had to focus on to prioritize the iPack deliverables.

Representing the SLCAA Director-General, the Director of Aviation Security and Facilitation, Kugbei Tucker stated that SLCAA considered the iPack implementation programme very much important, adding that the State had put together the National Air Transport Facilitation Programme Committee which had been in existence for five years.

"At the Airport level, we also have the facilitation committee and they meet regularly to look at concerns from the travelling public, but with the emergence of COVID-19, we must have an integrated approach to see how best we can collaborate as stakeholders in the Aviation Industry," Director Tucker explained during the Video Conference.

Director Tucker ended that SLCAA welcomes the idea and cannot wait to see the start of the implementation of this programme.

SLCAA'S AVSEC STAFF CONCLUDE SECURITY AUDITING TECHNIQUES COURSE




Aviation Security and Facilitation (AvSEC) staff at the Sierra Leone Civil Aviation Authority (SLCAA) have concluded a five-day course on Aviation Security Auditing Techniques.

Conducted by the Singapore Aviation Academy, the course aims at providing the required knowledge and skills in Aviation Security Auditing Techniques for AvSEC staff to effectively conduct compliance audits and manage quality control programmes.

This course also enhances the awareness of aviation security managers and supervisors on auditing procedures and techniques in line with the requirements of the International Civil Aviation Organization (ICAO) Annex 17 (Security) and the ICAO Document 8973 (Security Manual).

During the 2019 ICAO Universal Security Audit Programme (USAP) Continuous Monitoring Approach (CMA), it could be recalled that the SLCAA scored 71%, which is above the Regional Average of 65%.

Fourteen SLCAA staff and three Republic of Sierra Leone Arm Forces RSLAF personnel attached to the Air Wing at the Freetown International Airport (FNA), totalling seventeen participants, participated in the course.





Speaking on the impact of the five-day capacity building programme, Bamie Tua Penyikie, AvSEC officer, expressed elation in the content of the course. He said that the five-day course covered: Introduction to aviation security quality control, definition, and contents of audit/inspection programme, Preparation techniques for an audit/inspection, Audit/inspection methodology, Audit/inspection techniques, and Profile of the auditor, which he noted, are essential to his work. The SLCAA Director of Aviation Security and Facilitation, Kugbei Tucker, acknowledged the relevance of the course to the operations of Aviation Security and Facilitation at the Freetown International Airport, adding that: "With this training, the AvSEC staff have now gained the required knowledge in providing Aviation Security Oversight and helped us to understand in a better way how to carry out audit exercises at the Airport".

He continued by revealing that before now there were challenges in implementing the USAP CMA but the course has a platform to understand all the dynamics involved with better knowledge on pre, during and post aviation security audit exercises. He observed that this was one of the findings of the 2019 USAP CMA audit under Training and Certification. "We believe that during the next USAP CMA audit scheduled for 2022, SLCAA will be in a better position to score 85% and above", he said.

Director Tucker ended by expressing thanks and appreciation to the management of SLCAA for such an opportunity, adding that with this training, his staff now have the required knowledge to effectively prepare for an aviation security audit/inspection, conduct and document an aviation security audit/inspection and understand ICAO Standards and Recommended Practices (SARPs) on aviation security.

SLCAA, IOM LAUNCH COVID-19 ENTRY POINT PREPAREDNESS AND RESILIENCE PROJECT



Sierra Leone Civil Aviation Authority (SLCAA) and International Organization for Migration (IOM) have yesterday launched the project entitled: "Strengthen Health System Capacity, Preparedness, and Resilience in COVID-19 Points of Entry with Sierra Leone Diaspora."

The Preparedness and Resilience Project for Points of Entry (PoEs) is funded by the Japanese Government through its Embassy in West Africa.

The project's objective is to strengthen the capacity to prevent, detect, notify and respond to the risk of COVID-19 and other infectious disease outbreaks in selected Point of Entries (PoEs) and surrounding areas.

The Chairman of the project launch, Patrick Jaia Kaikai, who also doubles as the Chairman of the Board of Directors of SLCAA, in his remarks, expressed that the project launch was a manifestation of the call from HE President Julius Maada Bio on collaboration.

"Today, we are seeing a real example of collaboration and teamwork between agencies. This is a collaborative effort between the Sierra Leone Civil Aviation Authority (the regulator) and the Sierra Leone Airport Authority (the operator)," he said.

In his welcome statement, the General Manager of the Sierra Leone Airports Authority (SLAA), Jack Massaquoi said the project launch was a true meaning of working together to achieve a common objective in the Aviation Industry in Sierra Leone, stating further that the full implementation would open doors for more support from the people of Japan to the people of Sierra Leone.

IOM Project Manager, Kunikazu Akao revealed that since the confirmation of the first case of COVID-19 in Sierra Leone, IOM has actively supported the Government of Sierra Leone especially COVID-19 prevention at Points of Entry, conducting risk communication and community engagement as well as the provision of personal protective equipment to COVID-19 frontline workers and responders.



"To intensify COVID-19 response at PoEs, IOM in March 2021 started a one-year project with funding from the government of Japan. The project will strengthen capacities for COVID-19 prevention and response at main prioritized PoEs and surrounding health facilities", he ended.

SLCAA Corporate Planning and Research Officer, Sahr Emmanuel Joseph said that the Grant Assistance for Grassroots Human Security Projects (GGHSP) intended to provide social and economic development at the grass-roots level.

"SLCAA being eligible under the COVID-19 framework (specifically on Primary Health Care Facilities and Medical Equipment) applied for support toward building the capacity of the Airport safety oversight on the Airport Health Infrastructure as was stated in the Airport Council International (ACI) Airport Excellence APEX Safety report 2019", he noted.



Through the GGHSP grant framework, he said, SLCAA has been awarded grant support from the Japan Embassy for the provision of an Ambulance, a thermo camera, five wheelchairs, handheld thermometers and sets of face masks, hand sanitizers and other protective gears totaling \$53,645.

The Japanese Ambassador to Sierra Leone, HE Tsutomo Himeno, in his statement, said the reason they were keen on supporting the project hinged on the friendship between the people of Japan and the people of Sierra Leone, adding that the project came as a result of HE Julius Maada Bio's visit to Japan two years ago, during which he had meaningful discussions with the Japanese Prime Minister regarding development.

"Although we are far away, we have a very good relationship with the Republic of Sierra Leone, and that good relationship is built upon the bilateral engagement between the two countries".

Dr Amara Jambai, Deputy Minister of Health II also expressed his profound thanks and appreciation to the people of Japan through the Japanese Embassy for this great support to the people of Sierra Leone.

Representing the Hon. Giving feedback on the mission, Nuah E. Padmore, Head of the Liberian Delegation, expressed his profound thanks and appreciation to the SLCAA for rendering such important assistance in the area of Aviation Security and Facilitation.

He said the aim of their mission was for the SLCAA to assist LCAA in developing its aviation security oversight system by ensuring that Liberia meets the requirements to achieve a higher compliance rating with Annex 17 Standard and Recommended Practices (SARPs), during their scheduled document-based Universal Security Audit Programme (USAP) – Continuous Monitoring Approach (CMA) in August 2021.

"After the different presentations by the SLCAA and SLAA, the Mission was able to identify and understand gaps in the implementation of Annex 9 and Annex 17," Nuah E. Padmore revealed.

He further recommended that the SLCAA Aviation Security (AVSEC) team visit Liberia for a National Leadership discussion to buy the Sierra Leone model of implementation of Annex 17 requirements. Also, for the SLCAA to assist LCAA in the area of Primary and Secondary AVSEC Legislation and review of their AVSEC manuals.

Minister of Transport and Aviation would have loved to meet the Liberian delegation but unfortunately, he was out of the country.

"This is a national assignment we are all called to do. We will look at the recommendations you have made. These are not things we are averse to. We will do our bit in engaging higher Authority," DG Baio assured.

He expressed further that he is happy with the outcome of the Technical Assistance Mission while recalling SLCAA rendered similar assistance on Aviation Security and Facilitation to the Gambia Civil Aviation Authority in December 2020.

"We are pleased to share our experiences with our sister countries within the mano river union and hopeful for a positive impact on our collective effort towards enhancing our level of effective implementation of Annex 17 and 9 of the Chicago Convention," DG Baio said.

DG Baio, on behalf of the Minister of Transport and Aviation, presented gifts to the delegation and assured them of SLCAA's continued support in addressing their deficiencies in Annex 9 and 17.

"As a team, we were able to look at the Establishment of SL-AAIIB, Development of Legislation, Regulations, Manuals and Guidance Materials. We also looked at the development of training policies and programmes for investigators (Initial, Simulators and Specialized); and how the SL-AAIIB should prepare for ICAO Audits and the implementation of Corrective Action Plan, following any gap identified," he said.



In his statement, the SLCAA's Safety Manager/National Continuous Monitoring Coordinator (NCMC), Arnold Bangura, revealed that Accident Investigation issues are central to his scope as Safety Manager, hence his participation in the just-concluded exercise. He also expressed that he was grateful for such an opportunity, and promised they would do their best to ensure SL-AAIIB implement the recommendations emanated from the fact-finding mission.

Speaking on behalf of the SLCAA Director-General, the Director of Corporate Services, Alex Pratt, stated that: "Let me, on behalf of the Director-General, thank you very much for the work done in this brief period. The SLCAA welcomes the recommendations made so far, and promise they would be carefully followed and implemented," he said.

Director Pratt assured that the SLCAA will continue to give the necessary support, calling on the NAIB to also keep the SL-AAIIB at heart. "It is only with these supports the SL-AAIIB would be able to implement all the recommendations emanating from this fact-finding mission".

In his closing courtesy, SL-AAIIB Commissioner, Olubunmi Wellington, expressed his profound thanks to HE Dr Julius Maada Bio, for his approval on the setting up of the SL-AAIIB.

Commissioner Wellington further extended gratitude to the Nigeria Delegation for the technical support rendered in the establishment of the SL-AAIIB. "We promise to make good use of this opportunity and we will call on you at any time to play the Big-Brother-role you have already started".

AHEAD OF THE ICAO USOAP AUDIT 2022 SLCAA ORGANIZES INTERNAL MOCK AUDIT

In preparation for the International Civil Aviation Organization (ICAO) Universal Safety Oversight Audit Programme (USOAP) scheduled for April 2022, the Sierra Leone Civil Aviation Authority has concluded its second Mock Audit.

The three-day Mock Audit is part of CAA's activities to assess Sierra Leone's safety oversight capabilities in the areas of Legislation, Regulations, Technical Personnel and Training, Technical Guidance Materials (TGMs), among others.

USOAP audits focuses on the State's capability to provide safety oversight by assessing the effective and consistent implementation of Critical Elements (CEs) of a safety oversight system, which enables the State to ensure the implementation of ICAO's safety-related Standards and Recommended Practices (SARPs) and associated procedures and guidance materials.

During the exercise, various Heads of Departments stressed the significance of the Mock Audit and digressed on the Protocol Questions (PQs) intended to be assessed during the Universal Safety Oversight Audit Programme in 2022.

Highlighting the Protocol Questions (PQs) that the State will be audited on, the SLCAA's National Continuous Monitoring Coordinator (NCMC)/Safety Manager, Arnold Bangura, revealed that ICAO

has reviewed the PQs from 943 to 790, giving a breakdown on all the different audit areas. Presenting the Primary Aviation Legislation and associated Civil Aviation Regulations PQs, Director of Air Transport and Legal Services, Jusu Kallon, maintained that under Legislation, the State would be audited on 23 PQs, which invariably touch on all audit areas. On the self-assessment for Personnel Licensing and Training (PEL), Sheka Magona, PEL Manager, also noted that their area would be audited on 93 PQs, of which 71 PQs applicable to the state.



Aerodromes and Ground Aids (AGA) Officer, Prince Fillie, presenting on behalf of Aerodromes and Ground Aids Division, stated that there are 143 PQs related to the AGA Audit Area; 134 PQs applicable to the state, 32 PQs are satisfactory and 102 PQs are unsatisfactory; whilst Sahr Gando, Air Navigations Services (ANS) Manager presenting on their audit area, stated that their department has a total of 121 applicable PQs that would be audited.

Olubunmi Wellington, Sierra Leone's Aircraft Accident and Incident Investigations (AIG) Commissioner, stated that there are 84 PQs related to the AIG audit area, 12 PQs are satisfactory and 72 PQs is unsatisfactory.

In his statement to staff, the SLCAA Director-General, Moses Tiffa Baio, appraised the effort of all those who participated in the successful completion of the exercise, adding that for the State to pass the schedule ICAO USOAP Audit in April 2022, he was counting on the support of all staff. "Our main focus during this mock exercise is to make decisions based on data and not on assumptions. Let us see ourselves as a team, fighting for one objective with more determination so at the end of the day we will achieve our desired goal," DG Baio said.

DG Baio ended by stressing that Sierra Leone is a fertile ground for aviation within the sub-region, noting that staff should grab the opportunity to make Sierra Leone a global aviation hub. "All that was discussed during these three days were said in the spirit of National Development".

At the end of the exercise, the work-plan presented was validated and a road map developed which will guide the SLCAA on its implementation of the Corrective Action Plans (CAP) before the scheduled Audit.

MTA, SLCAA ENGAGE SERVICE PROVIDERS ON BETTER SERVICE DELIVERY



The Ministry of Transport and Aviation (MTA) in collaboration with the Sierra Leone Civil Aviation Authority (SLCAA) has engaged aviation service providers at the Freetown International Airport (FNA) on better service delivery.

In his statement, the Minister of Transport and Aviation, Kabineh Kallon, noted that there have been several complaints against airport workers for harassing passengers at arrival and departure, stating that the Ministry was going to change its monitoring and supervision strategies. He stressed that staff found in such activities would be dismissed and prosecuted in the court of law.

While admonishing them to learn from other airport operators within the sub-region, he explained the consequences of such an act, adding that it would muddle the image of the country and dampen the institution's reputation. "It will be an embarrassment to the airport and the country as a whole to see the photo of any staff making rounds on social media for baggage pilferage," the Minister stated.



act of baggage pilferage. He welcomed the Minister's statement of not only dismissing people but also prosecuting them in the court of law and assured the Minister of their support in tracking down all those that seem to be counterproductive to the development of the airport.

Giving the closing remarks, the SLCAA Director-General, Moses Tiffa Baio, expressed profound thanks to the Minister for his presence and level of commitment to the development of the aviation industry in Sierra Leone.

He further re-echoed that the meeting was not summoned for people to defend positions of their organizations but rather to speak on the many complaints that have been coming from the travelling public and find solutions to them.

"Aviation is guided by the International Civil Aviation Organization (ICAO), Standards and Recommended Practices (SARPs). If we adhere to all these regulations, practices, and or guiding principles we will not have been experiencing these problems," DG Baio said.

DG Baio disclosed they would not only move to the level of enforcement and prosecuting workers found in such an act, but they would also blacklist individuals. "We do not want to be recycling staff who are not professionals within the industry; we will move beyond those words now," he ended.

AIR SENEGAL COMMENCES FLIGHT OPERATIONS TO SIERRA LEONE



Ministry of Transport and Aviation (MTA) on Monday hosted the National Air Transport Facilitation Committee to discuss issues surrounding the passenger experience on arrival at the Freetown International Airport.

The main purpose of the meeting was to review the travel process at the Arrival Hall of the Freetown International Airport (FNA), identify gaps and bring out suggestions to address the gaps highlighted.

The Minister of Transport and Aviation, Hon. Kabineh Kallon, in his remarks, revealed that government was concerned about the state of affairs on the facilitation process implemented at the Freetown International Airport Lungi, adding that there were few concerns from the travelling public which, he believed, the committee should address.

"Since the reopening of the airport, I am pleased to inform you all that government is satisfied with the collaboration and cooperation between NaCOVERC and the Aviation Industry Stakeholders. The passenger processing on the arrival at FNA has posed very serious challenges for which we consider it as a cause for concern, which has the tendency to mitigate our desire to fly in or out of the country," the Minister said.

The Hon. Minister ended by calling on the committee to provide solutions to these problems and see how they could make the Air Transport Sector attractive and lively once again.

Giving the overview of the National Air Transport Facilitation Committee, the SLCAA Director-General, Moses Tiffa Baio noted that the National Air Transport Facilitation Programme was from our national laws, which was also a transposition from Annex 9 of the Chicago Convention of the International Civil Aviation Organization (ICAO).

"Principally, this talks about the expeditious movement of passengers in and out of the Freetown International Airport. But then, the emergence of COVID-19 has added another burden on the travelling public which is something we are not averse to some of the stringent measures that have been implemented as a result of the COVID-19 pandemic. What other airports are trying to do is to make sure that passengers travelling to different destinations do not experience more air travel ordeals," DG Baio observed.

DG Baio further stated that the Aviation Industry was struggling to get people back to flying and the committee's primary focus should basically look at some of the public health measures implemented at the airport.

"Specifically, we are looking at the arrival process from the moment passengers disembark from the aircraft go through the health protocol, the additional screening is done by SECURIPORT, Immigration, Customs, NaCOVERC and onto the last point in crossing over to Freetown without compromising the health protocols put in place, we need to see how best we can address some of these concerns from the travelling public," the DG said.

DG Baio reaffirmed that the Civil Aviation Authority was charged with the responsibility of implementing Annex 9 of the Chicago Convention of the International Civil Aviation Organization (ICAO). He concluded by admitting the Aviation Industry was glad that the issue of collecting passports from arriving passengers had been rescinded.

On the side of NaCOVERC, Col. Hassan Coomber, Operations Pillar Lead disclosed that they have been doing fine in terms of COVID-19 restrictions even though there is still a need for improvement. "We have taken off the inter-district restriction, as well as giving access to all passengers travelling through the airport," Col. Coomber stated.

Col. Coomber also expressed there had been overcrowding at the airport and this, according to NaCOVERC, is an alarming concern for the transmission of the virus. Based on this worrying development, he added, NaCOVERC had been engaging key stakeholders on the need to have a seamless process at the airport.

Representing the Sierra Leone Airport Authority (SLAA), the Deputy General Manager, Bobson Kargbo informed the Committee on the introduction of key health measures implemented at the airport to help prevent the spread of the COVID-19 pandemic. the Deputy GM added: "We have made it mandatory to wear a face mask at the airport. We have also installed handwashing facilities within the airport. We will also be embarking on massive public education to inform the travelling public about the health protocols that have been put in place."

On behalf of the Board of Airlines Representative (BAR), Estelle Van Eeckhout from Brussels Airlines confirmed the airport's congestion, adding that: "For the passenger Health Locator Forms (HLF), some Airlines do give it onboard the aircraft but we have noticed that the information they fill on the HLF is the same with what they filled on the travel portal," Estelle said.

The committee resolved that the SECURIPORT data collection system be merged with the Ministry of Health and Sanitation DHIS 2 system, to mitigate the duplication of data collection at the airport.

SLWIA RAISES FOD AWARENESS CAMPAIGN



The Sierra Leone Women in Aviation (SLWIA) in collaboration with Sierra Leone Civil Aviation Authority (SLCAA) and the Sierra Leone Airport Authority (SLAA) has engaged other Aviation Stakeholders in raising awareness on Foreign Object Debris (FOD).

Foreign Object Debris (FOD) at airports is any object found in an inappropriate location that, as a result of being in that location, can damage equipment or injure personnel. They include a wide range of materials: loose hardware, pavement fragments, catering supplies, building materials, rocks, sand, pieces of luggage, and even wildlife.

In her statement, the President of SLWIA, Mallay Betty Braima, said their association was established in August 2015 by 14 Female Aviation Professionals spanning various sectors of the aviation industry.

"The objective of our association is to promote the current career growth of our members, create access to other industry professionals, inspire young women to consider aviation as a career path, organise outreach programmes and forums for school pupils, and partner with similar international chapters of women in aviation for program exchanges and career development," she added.



Speaking on behalf of the SLCAA Director-General, the SLCAA State Safety Manager, Arnold Bangura, stated: "We are here today to mark another achievement from a group of women who have decided to make their mark in the aviation industry in Sierra Leone with the exercise of raising awareness on the negative effect of FOD in aviation".

Arnold Bangura maintained that as part of the SLWIA initiative to promote aviation safety and in consultation with the SLCAA and SLAA, SLWIA has decided to organise FOD awareness campaign to provide the industry and community with muchneeded information on the effect of FODs and wildlife in the vicinity of an airport and associated safety impact.

On behalf of the Board of Directors and Management of SLCAA, he thanked SLWIA for organizing such a landmark event and further call on them to continue in this trajectory.

The General Manager of the Sierra Leone Airport Authority (SLAA), Jack Massaquoi, noted he was elated to witness the campaign on Foreign Object Debris which hinged on promoting safety at the Freetown International Airport (FNA), the only gateway to Sierra Leone by air.

He said the theme for the campaign "Making FNA, FOD Free" sends a loud message not only to stakeholders within the aviation industry, but also the country at large about the effect of Foreign Object Debris.

In her keynote address, the SLCAA Aerodrome and Ground Aids Manager, Ing. Lyat Mason, who doubles as the Vice President of SLWIA, stated that the continuous improvement in global aviation safety is fundamental to ensuring that air transport continues to play a major role in driving sustainable economic and social development around the world.

"To ensure safety Standards are implemented at Aerodromes, ICAO has mandated States to Certify Aerodromes used for International operations. This process ensures the establishment and implementation of an aerodromes Safety Management System," she said.

Ing. Mason further revealed that the presence of FOD at airport operating areas poses a significant threat to the safety of air travel, as it has the potential to damage aircraft during critical phases of flight, which can lead to catastrophic loss of life and equipment, and at the very least increase maintenance and operating costs.

She ended that FOD Prevention and clearance are the responsibility of all airport users. "All personnel involved with operations, construction and maintenance at the airside, have equal responsibility to ensure their particular operation does not give rise to FODs". She calls on all aviation stakeholders to make the Freetown International Airport FOD free.

SLCAA, ONS & CISU ENGAGES AVIATION SECURITY STAKEHOLDERS ON NCASCP

The Sierra Leone Civil Aviation Authority (SLCAA), Office of National Security (ONS), and Central Intelligence Security Unit (CISU) have engaged Aviation Security Stakeholders on the validation of the National Civil Aviation Security Contingency Plan (NCASCP).

In his opening remarks, the ONS Chief of Staff, Dr. Ahmed A. Sannoh, started by recognizing the good work of the SLCAA: "may I recognize the presence of the Director-General of SLCAA for gracing this occasion. His passion for aviation has led to the new face that SLCAA has had in recent time, and if you interact with him you will prove that to be so," he said.

"We are here today within the context of fighting a global scourge, that is terrorism. Terrorism is a global existential threat and therefore any country that is worth its salt should do everything it should to make sure that it has adopted the requisite strategies, provisions, legislations, and regulations to be able to deter the threat that may be posed by terrorism," Dr. Sannoh maintained.

He ended that aviation security stakeholders should work hard to externalize this reality as they are meeting to validate such an important document that will complement the efforts towards fighting terrorism.

The SLCAA Director-General, Moses Tiffa Baio, in his short statement expressed profound thanks and appreciation to all in attendance for their participation. "As Aviation Security Stakeholders, we are here to review and validate the State National Policy document on Aviation Security, which the technical team has been doing behind the scene. A lot of consultations have been done, and we are still following the same process as we have been doing with other stakeholders," DG Baio said.

DG Baio believed that the document that will be produced will be able to meet the requirements of the International Civil Aviation Organization (ICAO) and that of our national requirements. He calls on all stakeholders present to participate fully and wished a fruitful deliberation and positive outcome.

Presenting the National Civil Aviation Security Contingency Plan (NCASCP), the SLCAA Director of Aviation Security and Facilitation, Kugbei Tucker, revealed that in both the 2013 and 2019 ICAO Universal Security Audit Programme Continuous Monitory Approach (USAP-CMA), the State had findings on this area.

"Since the event of 9/11, the world has witnessed a dramatic shift in Aviation Security, from small border control unit with limited systems and procedures to a comprehensive approach directed towards safety and security of passengers, aircraft, terminal buildings, and other facilities at major international airports," Director Tucker underscored.

Director Tucker further added that as a logical step forward in addressing the huge challenges associated with: unlawful seizure of aircraft, terrorist attacks, sabotage, hostage-taking, and its attendant problems, the SLCAA has developed a draft Contingency Plan that can be used to respond to these incidents.

He concluded that ICAO recommends each contracting State to ensure that contingency plans are developed and resources made available to safeguard civil aviation against acts of unlawful inference and that the contingency plans shall be tested regularly.
